Timelines for Spot Round for Admission to Four-Year Undergraduate Programs (FYUGP) / Integrated P.G. Programs with multiple-exit options for the Academic Session 2025-2026.

The Department of Higher Education Government of Jammu & Kashmir vide No: DCHE/2025/1152 Dated: 15-06-2025 announced the commencement of admissions for the Academic Session 2025-26 for various Four Year Undergraduate Programs (FYUGP) / 5- Year Integrated P.G. Programs (IG) with multiple-exit options across all Degree colleges of J&K, for the Academic Session 2025-2026. Subsequently, the timelines were revised as per notification Nos: DC/HE/2025/276 dated 07-07-2025 and DC/HE/2025/276 dated 07-07-2025 and DC-HE/2025/1409 dated 21-07-2025

Now after completion of the first 3 admission rounds, Spot-Admissions for leftover seats to all colleges of J&K will be conducted as per the timelines detailed below:

1	Spot-Round for CUET COLLEGES (Listed in Annexure A & C) as well as For NON-CUET COLLEGES (Listed in Annexure B) for Leftover seats • The interface for registration and selection of programs and colleges shall be activated from 1st August 2025 on the Samarth Portal, thereby enabling aspirants to apply for spot admissions. All eligible candidates interested in participating in the Spot Round are required to complete the Registration and College/Program selection within the stipulated timeline. • Colleges shall grant admission as per the following criteria: • Wherever more than 30% seats of a major subject are vacant, the college shall admit students on First-Come-First-Serve basis. • Wherever less than 30% seats of a major subject are vacant, the college shall prepare and publish on the college website subject-wise merit-lists of students who have applied therein on the basis of 10+2 Merit. • For admission related information, candidates will be required to keep checking the website of the colleges they have applied to. • Candidates who have not registered in previous rounds owing to late declaration of result or due to any other issue, can also register during this period and apply for admission to various colleges. • Publication of Merit/Selection Lists by Colleges: 04 August 2025 onwards • Last Date of Fee Payment • Closure of Spot Round • Ochagust-2025	1st to 3rd August 2025
2	Completion of pending admission formalities Candidates who had been allotted colleges in any previous rounds but had been unable to complete admission formalities due to non-payment of fee, missing deadlines or any other issues, can visit the colleges allotted to them in previous rounds and complete their admission formalities.	1st to 3rd August 2025
3	Shifting of students for Majors with Low Enrollment In case the number of admissions in a particular major falls below the prescribed limit set by JKHED, the students shall be shifted to another college/major.	06 th to 10 th August, 2025
4	Completion of Admission Process	10th August 2025
